## **Standing Orders**

In order that the proceedings of the convention be carried out without delay the following Standing Orders will be observed: -

- 1. The Proposer of a Resolution, or Amendment thereto, may speak for 5 minutes but no longer.
- 2. A Delegate speaking to a Resolution or Amendment shall not exceed 3 minutes.
- 3. The Proposer of a Resolution, or Amendment, may speak a second time for 5 minutes, before a vote is taken, but no other Delegate may speak a second time to any Resolution or Amendment.
- 4. The Chairman shall, at any time he considers a matter has been sufficiently discussed, call on the Proposer to reply, after which a vote will be taken.
- 5. A Delegate may, with the consent of the Chairman, move "that the question be now put" after which, when the Proposer has spoken, a vote must be taken.

- Standing Orders adopted on the proposition of Tomas Mac Seoin, seconded by Briain Ó Rannacháin.
- Minutes of 2022 Convention adopted on the proposition of Pilib Ó Céin, seconded by Ursuile Ní Dhonnchaidh.
- Secretary's Report adopted on the proposition of Liam Ó Braonáín, seconded by Caoimhín Ó Greacháín.
- 4. Treasurer's Report showing an operating surplus of €231,755 in County Committee A/c and a deficit of €11,607 in O'Moore Park A/c were adopted on the proposition of Máirc Mac Pheadair, seconded by Daithí Ó Duibhir. An Cisteoir gave a detailed explanation of our financial accounts, explaining both Income and Expenditure Accounts and Schedules to accounts. He stated that the decrease in Gate Receipts was perhaps a truer reflection of our operating income, and that the previous year's Gate Receipts were distorted due to a large proportion of 2022 Championship games being delayed due to Covid. He informed delegates that this was an exceptional year on our finances and that we must continue to be prudent with the management of our finances. He noted particular caution to the area of our Inter-county team administration expenses, which he continued to increase with expenditure this year of €860k, which he believed is not sustainable. He acknowledged the co-operation and support of our Clubs in our main fundraiser, €130 All Club County Members Draw and appealed for their support again in 2023. He thanked our main sponsor Laois Hire for their dedicated support also thanked our other sponsors Magni Group, O'Neills, LOETB, Laois Shopping Centre, Midlands Park Hotel, ENVA, LSM, Glanbia, Tom Brennan for their continued support. He thanked Mairtín Ó Broin, Niall Mac Laitimh & Briain Ó Braoin for their co-operation in updating and preparation of accounts and his fellow Executive members for their dedication and support, while also acknowledging our Clubs for their co-operation with gate collections and our O'Moore Park stewards and gate staff, without whose availability we would be unable to function.

## Matters arising from Treasurer's Report:

- P. Ó Néil Portlaoise complimented An Runaí and An Cisteoir on comprehensive reports to Convention and expressed his concern on increase to intercountry team administration to €860k, stating that if caution is not exercised we will soon be exceeding €1million, which he believed not to be sustainable to a county like Laois;
- O. Ó Greachaín Maighean Rátha queried as to where our intercountry team administration was in comparable to other counties and his belief was that cutting back was not the way forward and outlined business men who have recently located in Laois be approached about additional sponsorship;
- o P. Ó Ceín An Fraoch asked as to whether GPA demands had any significance on increasing our intercountry team administration expense. An Cathaoirleach informed delegates that the Players Charter is agreed annually with Croke Park representatives

- and that the GPA do have a significant input, particularly in relation to mileage and meal allowance:
- L. Ó Rannacháin Tigh Mochua stated that in his opinion that there is no chance of current figures coming down in the current economic climate and encouraged Clubs to support Laois GAA fundraisers with particular reference to Punchestown Race Day in April;
- o T. Mac Seoin An Fraoch reference expense for stewarding outlined in Treasurers Report, stating that all stewards participated in this discipline on a voluntary basis. An Runái stated that this expense referred to steward training which had been carried out last spring.

#### 5. Chairperson's Address:

Ba mhaith lion fáilte mór a chur roimh gach duine go dtí an comhdháil bhliantúil. I would like to extend a warm welcome to everyone here tonight to our Annual Convention.

Tonight we close another year in the history of the Gaelic Athletic Association in our County. In doing so, it is right and customary that we begin by remembering all those who have gone before us, and those who have gone to their eternal rest in the last twelve months. Ar dheis Dé go raibh a hanam.

The past year has been busy, containing some highs, some lows and everything in between as detailed in the reports contained in our Convention booklet. Our County secretary Niall Handy has compiled our annual report for 2023 convention and if you haven't read it already, I suggest you do as it gives a detailed account of all activities that took place throughout the year. I want to thank Niall for his work and commitment during the year and his attention to detail in all aspects of his role as County Secretary, he has been a great help to me. Really appreciated Niall, and likewise to my Vice-Chairperson Kieran Kehoe for his continued support and advice, thank you Kieran.

As per last year, I don't propose to revisit all aspects of Laois GAA in my address but rather share my perspective on some of the year's events with an eye to the future."

Discipline has once again been a huge topic within our County this year and un-

fortunately during the 2023 fixture calendar, individual and sporadic instances of unsporting and downright thuggish behaviour presented, and in my view, these are unacceptable and indeed a major threat to what we stand for as a people. We all have responsibility when it comes to discipline be it from the stands on our side-lines or the players that take the field. Notwithstanding the successful recruitment of referees this year, we are still on a similar number to last year post retirements etc. and who can blame someone for not wanting to take up the whistle if the threat of abuse is so probable. I implore all our members to think before you react to a decision during a game as all our attitudes must change or we simply won't have anyone to referee our games in the future. We cannot stand back, however, and ignore instances

where match officials and players, and indeed volunteers are abused, either verbally or physically.

Likewise, referees need to be exemplars of respect, be it on the field or when dealing with representatives of our Referees appointment committee or staff of Laois GAA. Accordingly, I would like to thank our Referee's Administrator Vincent Dowling, Secretary, Danny Gorman, and all other committee members for their time and expertise afforded to Laois GAA and for their assistance in appointing, educating and assisting referees on match days during the year.

I want to urge everyone to reflect on this ahead of the 2024 season, particularly at underage games where impressionable children are present. For this to happen we need to in still a culture of respect, and we have a responsibility as a collective Organisation to ensure that we control the culture at our games.

Accordingly, I want to thank all the referees and other match officials who have made our games possible over the season just gone. It's a cliché at this point but without them, there would be no games. We have some of the leading officials in Laois, and it is vital that we utilise their experience in bringing forward a new generation of officials. However, we need a culture of respect for this to be as successful as it needs to be.

#### Laois Hire O'Moore Park & the LOETB Centre of Excellence.

Our LOETB COE here in Portlaoise has become a massive social hub of positivity within our County. As a Unit, it has enhanced not only our asset wealth but also our player participation and retention, it's a state-of-the-art training facility that can and has been utilised to its capacity, and perhaps beyond at times.

I firmly believe that the LOETB COE along with Laois Hire OMP has become a conduit of unity within our County. The very strong sense of pride and satisfaction is palpable amongst our patrons and players alike that have attended games, training sessions or even practice matches this season. These are always seen as an extension to our own local club facilities.

A lot of decisions have been made around this facility over the past few years and we have tried earnestly to be as pragmatic as possible with every decision taken, none more so than the recent irrigation project, and the provision of new stand seats. Both projects jointly costing in the region of half a million euros. This newly refurbished stand can hopefully add to match day comfort for our spectators. Unlike others, we have not asked any of our units for extra monies towards upgrade works/new projects during 2023 as clearly outlined in our Safety & Facilities report.

Looking forward to 2024, I would envisage a greater focus regards a needs assessment for the construction of a 4 G pitch and upgrading our stand facilities to ensure that those with disabilities, can enjoy an unrivalled event day experience. The guiding principle for this is that visitors with disabilities are accommodated and have the necessary facilities available to meet their needs. Furthermore, the provision of a new electronic scoreboard is imminent. All positive when brought to fruition.

I want to thank everyone involved with maintaining these grounds and for offering their continued hard work, especially: John Kelly, Colm McEvoy & his fellow workers, including Mick Glynn and Willie Stackpool.

#### County Teams & County Representation

Delegates, except for our U20 Football B Championship Final, we have concluded our on-field activities for 2023 and tonight I had intended to give my own brief synopsis on team performances during 2023. However, instead I want to share with you instead some alarming sentiments brought to my attention in recent weeks from certain quarters.

It appears to be the view of some, may I say the 'minority folk', whether speaking on their own behalf or on behalf of their respective club(s), that they will not be encouraging any of their players to go into the Laois set up as the County seemingly don't care about player welfare.

I as County Chairperson, strongly refute this and see this as totally inaccurate and a blatant mistruth.

In support of my argument, Laois GAA see's the player as central to all its activities and one of our key objectives every year is to enhance the experience of all our players within Laois GAA. Among the key areas of player welfare focused on in Laois GAA include:

- · Support for injured players through the Player Injury Scheme
- Our bespoke contract commitment with UPMC which includes:
  - o Priority access to diagnostics (MRI, Dexa, X-Ray, CT-Scan)
  - o Priority access to a specialist orthopaedic consultant.
  - o Priority access to additional medical services within our hospital network.
  - o Access to Sports Science supports.
  - o FREE Baseline Concussion Assessments and priority access to specialist consultant
  - o Priority access to Sports Physician and Physiotherapy team
  - o Specialist equipment access to minimise recovery times.

And finally Counselling supports in areas such as:

Anxiety – Depression – Bereavement – Relationship issues – Family issues – Addiction treatment are always available

Hence, I firmly believe that Laois GAA can be proud of its overall record of looking after its players. Of course there is room for improvement. Of course, we must continue to learn and develop new welfare initiatives as new challenges emerge. And yes, Laois GAA are committed to doing that.

Furthermore, as Chairperson the two most challenging aspects for me is overseeing our annual fixtures calendar and appointing competent managers / management teams for the betterment of all involved. And to be told that a young Laois hurler or footballer may be discouraged from representing their own County, is totally unethical and for me personally, an injustice and a wrong is bestowed on such young Gaels.

In reflection of the aforementioned, for 2024 I ask that all us loyal Gaels to encourage, at every opportunity our young talent to make themselves available and proudly represent their County if and when afforded the opportunity.

Continuing, I want to thank all players who have represented their club and their County over the past year. I am fully aware of the sacrifices made by many. Likewise, to all outgoing management teams, thank you for all you have given to Laois GAA. Accordingly, I take this opportunity to wish all County Teams including management well for 2024.

And on a very positive note, my congratulations to Stephen 'Picky' Maher (Clough-Ballacolla) who was selected on the Joe McDonagh Cup 'Team of The Year', in recognition of his outstanding displays and I hope this award will be honoured and celebrated by both his family and his club.

#### Fixtures

The split season is still novel perhaps and may have some advantages. For example, clubs are provided with some clarity which is to be welcomed of course. However, the split has also presented challenges which we had to acknowledge and overcome. In Laois, I know our fixtures Secretary Niall Handy (and indeed all fixture committee members) endeavours each year to provide a clear vision and games programme which respects all the players who play our games at club and County level.

There has been an inordinate number of requests from some Club Secretary's and managers regarding rescheduling of fixtures this year. As a committee, such requests are heard and discussed and where possible facilitated. However, I would plead with clubs here tonight to understand our predicament, that all requests for rescheduling fixtures cannot be facilitated for reasons such as dual players, dual clubs, schools matches, Leinster Competitions etc.

Continuing, as stated at last year's Convention, an undertaking was given to discuss further the viability of a new senior hurling championship format. Accordingly, both a hurling and football review was facilitated for with the clubs. From a hurling perspective, some clubs expressed an interest in exploring a 10 or 12 Team senior championship, whilst staying as status quo was also a probable option. As we now know, the hurling championship remains as was for 2024, and change will happen in 2025, when we see the start of a new 10 team senior hurling championship, and the relevant changes to grades thereunder.

From a football perspective, this year saw the introduction of both a Senior B competition and Intermediate alike. Clubs' response regarding same was very positive from a Senior B perspective. However, there was some concern, albeit minimal, to the value of the Intermediate B competition, considering no final took place owing to unavailability of enough players from one of the finalist. General consensus was to run again as is for 2024.

We seldom see or hear about the good things which happen, day in, day out, but they are there, and we shouldn't lose sight of the fact that we do have a special and unique Organisation, one that can facilitate change as outlined earlier. The GAA still holds a massive place in society around the Country. Clubs are seen as pillars of the Community, a refuge in times of struggles and a billboard for showing off our great achievements.

However, more and more Gaels are now rightly expressing how slowly but surely the joy is being taken out of our games. Those of us who's affection for hurling and football runs deep in our psychic, are now asking 'are we been offered the best possible games experience for players and spectators alike'? personally, I say we're NOT!! Have I got the ultimate solution, no I don't, but I do think we need to be proactive and intuitive and encourage more risk-taking and incentives same. At the very least, we must experiment without delay.

### Sponsors

The sustainable financing of all our units is of paramount importance. We have a duty of care to see that our clubs and our County is on a sound financial footing at all times. Thankfully, our financial statements reflect this.

To our main sponsor Laois Hire, I want to express our deepest appreciation to John Killeen & Keith McCann who have committed to supporting Laois GAA for the coming 4 years. This is a significant pronouncement to Laois as we strive to achieve optimal outcomes. Similarly, thanks to The Magi Group, Laois/Offaly Education Training Board, Enva & The Midlands Park Hotel, for their generous and continued support. Going forward Laois GAA must generate sufficient sponsors for us to maintain and enhance current structures and facilities. This would not be possible without the hard work and due diligence of Pascal McEvoy and his Finance Committee. In the true ethos of CLG, our largest single sponsor is in fact ourselves.

In addition, Laois Gaels through men and women give voluntary contributions, asking nothing in return, only to see their County to progress on and off the field. I want to thank each and every club, and member of Laois Gaels and in particular the hardworking committee members and in particular Leo Turley and Brian Breen.

Can I take this opportunity to wish Leo Turley well in the further, as he now steps down from his role as Chairperson of Laois Gaels, and to the in-coming chairperson 'Colm Begley', we look forward to working together to further enhance the work of your predecessor.

I always championed the very real benefits of club and county working in unison for the betterment of CLG in our County. I want to commend all our clubs on being extremely resolute and pragmatic during the year when faced with difficult times and sad experiences.

The easiest thing in the world is to despair and become inward looking. However, our clubs have come through such tragedy's and, in doing so, demonstrated their commitment to their people and families in their local communities.

Continuing, the developments going on at many clubs are an inspiration and showcase of just what an important focal point of the community our Association was and is. We have seen an exponential growth in the use of social media in the association. Social media is a wonderful tool for the promotion of our games, but it also has great destructive power when used recklessly, and in my opinion, is often a negative distraction to our members.

I would urge all clubs and all coaches and managers within clubs to conduct training and awareness programmes around responsible use of social media for all your members and players, particularly younger players.

We need to create a responsible and considerate culture in this area going forward. We cannot ignore this challenge. To do so would be negligent in the protection of our youth. Your personal reputation is at stake and also that of our Association. Act in haste, repent at your leisure."

Equally as important is the role of more traditional forms of media. In Laois, our games enjoy widespread exposure. I want to thank all the reporters and photographers for their coverage of our Gaelic games in 2023. Our aim is to have an efficient and professional relationship with all forms of media, whilst accepting this may not always be achievable.

I also want to acknowledge our insightful partnership with Clubber TV. One of our foremost thoughts as a management team was how do we, 'Laois GAA' grow and attract a broader base for our games. I think this partnership with Clubber TV gives us not only the ability to give people greater access to games they may not otherwise have seen, but it also guarantees a consistent level of match day production, aligned with the proposition of giving viewers 'the best seat in the house', when viewers can't be in 'Laois Hire' O' Moore Park.

As we know, Gaelic games can provide chaos, and that is its glory. Anything can happen. Accordingly, I do feel that this should be a partnership, a partnership of equals, and I hope this is the start of great relationship for both Laois GAA and Clubber TV, and indeed prospective viewers alike."

### **Executive & County Committees.**

Over the years, many people have served diligently in different roles and on various County committees. This work is vital to the running of our County schedule of activities and I want to thank each and every one of them for their efforts.

I also want to urge caution. As you'll see here this evening, we have none of elected positions contested on our Management committee. It's very disappointing and it means one of two things: either everyone is entirely satisfied with everything that is being done, or there is a degree of apathy towards executive roles.

Neither is a healthy state of being in my view.

If we do not see more people coming forward into leadership and committee roles, then we will suffer collectively. Much of the good work which has been done at club and County level can quickly be lost if we do not start to develop a greater culture of collective responsibility. We have too many people too quick to criticise, yet slow to help out.

This isn't just at County level; it's an issue at club level too. In a way, I'm preaching to the converted here tonight. Volunteers are being squeezed with more and more demands on their time with an ever-increasing workload on serving at County board level or indeed club level. Make your clubs inclusive and welcoming places and also help to foster an awareness of the fact that County committees also need people to survive and function properly. I cannot stress that enough.

#### Coaching & Games

It was another busy year in our Coaching and Games department and the full details of all activities are contained in the convention booklet. When talking about games, Youth & Coaching are very much to the fore for us all. I believe the club with active Coaching Officer (s) will be the club who will reap the most reward. To try to help every club to progress further in these areas I will be asking the incoming Steering Committee to oversee the review and updating of our current Player Pathway for the County which in turn clubs will feed into. It's aim will be to pinpoint the issues clubs face in retaining young people and what more we can do to ensure our youth are continually attracted to our games.

Following this, our Committee will be asked to address the barriers facing our coaches. Most coaches get involved as they believe they can make a difference. What we aim to do is assist them to achieve this goal – in Laois that will involve recruiting the best possible coaches and mentors, ably led by our Games Manager 'Shane Keegan' and supported by our GDA's and GPO's alike.

Similarly, I will also be asking our Referees Committee to look into a similar recruitment for Development Squad referees with the aim of producing a batch of young referees wishing to progress and assisting them in that aim.

I want to thank Brian Quinn our Coaching Officer whom I think has contribute significantly over the last 12 months in the area of recruitment, be it Games Manager, GDA's, GPO's etc, I think we can look forward to a freshness and exciting time ahead with a lot of new faces aboard.

#### Integration

Efforts on the continued integration of all Gaelic games to include Ladies Football and Camogie within the wider GAA are currently underway at National Level. In many ways, we are ahead of the curve.

All codes enjoy and make use of the facilities here at LOETB COE & Laois HIRE OMP where feasible. Working together for the promotion of all Gaelic games is very much part of our overall ethos.

Furthermore, in recent years the involvement of women has been muted as revolutionised both Gaelic games and their administration. Last year's congress voted overwhelmingly to advance the process of integration, but it comes with challenges. Delegates, I'm on record in Croke Park (Chairpersons Quarterly Meeting) expressing my views that both the LGFA and Camogie must first come together, show they can operate and cooperate before we the GAA can even consider coming up with a road map as to how this will be brought to a successful conclusion. This is similar to views our former Uachtaran (Liam O' Neill) expressed shortly after his term of office, when he said for integration to happen and evolve, both the above parties should come together as one.

Interestingly, Mary McAleese sentiments as expressed on her recent Late Late Show appearance, in my view has perhaps given a false picture of where integration is actually at. Furthermore, it has afforded certain stakeholders a level of expectations, which in reality is untrue expectations, that cannot be met without investment on many

fronts from investors external to all parties e.g. Government funding and serious funding at that.

In addition, I would also like to draw your attention to pressure we as County Boards are experience as a result of statements from certain individuals from the GPA, for some reason say 'We will be ready to mobilise' - Warning if female inter-county charter not in place. The GPA has promised to be 'organised and mobilised' for 'any eventuality' going forward. As chairperson of Laois GAA, I firmly believe such statements are far from constructive or indeed helpful.

The pace at which this is evolving must be paused, until we have a clearer and more strategic vision as to where, how and when this can be a genuine reality.

Just as integration has supplemented both playing and administrative numbers in rural areas, the boom in women's games, places significant and maybe unrealistic demands on our current facilities and additional pressure on a poor public recreation infrastructure.

#### Demographics

Changing demographics leave rural and urban clubs with major challenges. In the face of a rapidly evolving society many clubs struggle to find players while bigger clubs can't find anywhere to play.

As outlined more than 50 years ago, the McNamee Commission, the first in-depth study undertaken by the Association, stated an essential and ever present difficulty. "The GAA is concerned with all the people of Ireland, urban and rural. The problem is that the association is weakest where the population is increasing; it is strongest where the population is declining. That problem has always been there but the extent of the adverse trends in recent years has now brought a full realisation of its seriousness for the association."

In light of this Laois GAA are please to say that Adrianne McCarthy (Portarlington GAA) will be proposed for the role of Demographics Officer and it is envisaged Adrianne will be best equipped to support any such challenges clubs may face.

#### Governance & Volunteerism

A Governance Review undertaken with the Audit Department in Croke Park has identified key compliance areas, including establishing a Governance & Audit Committee, independent of our County Executive. This committee advises and supports our County Board regards operating to the necessary standards and good practices.

Laois GAA is an ever-evolving Organisation and has grown year on year and requires a large number of volunteers and committee members to assist with the running of our County. I would like to thank all our volunteers and Sub-Committee members who work tirelessly behind the scenes to ensure we operate to very high standards across so many different fronts.

Accordingly, the main governance challenge facing the association from my own view-point is 'volunteers' being held to account in areas where they may not have adequate time to dedicate themselves to, or sufficient expertise.

The GAA has become more and more professional in how it's operated and what is expected of its units, which is not a bad thing, but what County officers are now being asked to deal with is, possibly, going beyond the limit of what a volunteer can do. "The workload and expectations of our volunteers, at all levels, has increased at an exponential rate. The challenge we face on foot of this is attracting and keeping good people involved,". People must remember that the officers carry out their duties in a voluntary capacity and, while we don't always do things right, we do try our best for Laois GAA."

"I worry are we saying these are roles that can only be done by someone who is retired, somebody who has a less demanding job or, perhaps, someone who doesn't have family commitments. There are so many ways we are excluding people from possibly becoming County board/club officers because of the demands placed on us."

"Do we need a strategy as an Association overall for how we operate in terms of our paid staff and volunteers?

All (of) this inter-county activity, never mind all the other different parts that make up our Organisation in our County, comes at a cost, and as you will have seen in our Treasurer presentation of the accounts, we are still committed to a sizable debt which we're oblige and committed to repay, Again, I want to thank our loyal supporters who travelled around the Country, including across the water, in support of all our County teams we really appreciate your support.

#### Scor

I want to acknowledge the Scor Committee for the promotion of Scor Sinsear agus Scor na nOg but we would love to see more clubs getting involved. However, the clubs that entered such competitions aquited themselves very well and I want to thank our Culture Officer, Noel Stapleton in this regard.

## Closing remarks

Finally, as I assume the role of Chairperson for 2024, on a personal note I'd like to thank my colleagues on the Management Committee and County Committee for their work and support all year and many others who have helped in various ways. We win together and we lose together.

A special word of thanks to our outgoing PRO Richard Kennedy who is not seeking re-election for 2024. A familiar sight wherever Laois play—thanks for your contribution and your vision for a better Laois Richie.

Similarly, Coiste na nÓg continues to provide an excellent introduction to competition for our young players and a sincere thanks to Joe and Tony, it was much appreciated, albeit an onerous task.

We don't say thank-you enough in the GAA, but I want us ALL to collectively thank and acknowledge the work we all do. Can I ask you to turn to the person(s) beside you and just shake their hand and say thanks, thanks for all you have done for the GAA in our Club and County.

On a personal note, it has been a year filled with challenges, a year that has tested the rule book on occasions, seen the implementation of more Regulations, the introduction of Codes into our games, democracy been practiced for the good of Laois GAA,

but all in all, a year that I believe has seen change, be it organisational change, be it our games assembly e.g. our 2023 football competitions and our hurling make-up for 2025, change in some of our administrative roles, additional GPO's, change to how we promote and provide coverage of our games. This I believe is change for the betterment of Laois GAA.

There are so many people who give their best for Laois GAA throughout the year and their efforts are recognised and very much appreciated. I'd like to thank everyone who makes that effort – in your club, as a delegate, on a committee, preparing pitches, acting as event Controller (Tom Jones) a steward, as a player, as a coach, as a referee – it sounds like a cliché but it truly does take us all. Also to our new office administrator, Pam Cooney, I wish you well in your new role and I know feedback from the clubs dealing with Pam, is nothing other than positive.

In Conclusion, we all look forward to the new year with enthusiasm and renewed determination to keep Cumann Luchleas Gael Laois at the forefront of all facets of our Association.

I wish all our Club units, our County Teams, our staff, each and every friend and member of Laois GAA, wherever they may reside, a very peaceful Christmas, and a healthy, happy sporting New Year.

January, where representation would be as at County Committee and nomination papers to be circulated later this week.

All elected officers acknowledged their Club for their nomination and thanked convention for their election to respective management roles.

7. Coaching and Games Overview - Shane Keegan Head of Games Development briefed delegates on our current Coaching and Games team, who have settled in well to the role and will now endeavour to work hard across a multiple of facets in the year ahead in an effort to do everything they can to help take Laois GAA in a forward direction. He outlined a brief synopsis of each of these sectors, incorporating present GPO's and plans to increase these personnel; plans for rollout of Formal Coach Education and Informal Coach Education; Go Games and importance of providing a regular programme of games for kids, in a non-competitive environment; our Academy squads and roles of Donie Brennan in Football and Ross Young in Hurling; successful Setanta and Ó Mórdha Óg programmes and plans for 2024; Primary Schools and role of our GPO's and GDA's engaging with kids at this age in developing a love of Gaelic Games at this age and increasing participation in our Clubs with this engagement; Secondary Schools and the challenges we face in getting students and teachers on board at this level; Athletic Development, under the tuition of our Head of Athletic Development Tom Hargroves and Performance GDA Brian Ging, with our Academy and Intercounty panels and plans to assist Clubs with their own Athletic development plans and finally the promotion of our games with increased social media presence and further interaction by means of mascots for county games, mini matches at half time, competitions and engagement of county and former county players in coaching workshops. He concluded by stating is availability to liaise with our Clubs on all matters Coaching and Games and willingness to take advice and direction from same in this sector.

#### 8. Motions -

 That a Clubs second or additional team can go forward to the Leinster Club championship if they win their County championship at that grade (Cumann Ná Clairsigh)

The Motion was passed unanimously on a show of hands after being proposed by Eanna Ó Faoláin and seconded by Ursula Ní Dhonnchaidh.

An Runaí stated that this was considered to be an amendment to "Code" 11.5 (a) (ii) and in his opinion needed to be ratified by Central Council, rather than Congress. He asked Ná Clairsigh representatives permission to put in rule format, to which they agreed.

 In accordance with the Official Guide 2023, Part 1, Appendix 4, Club Constitution, Executive Committee, 7.19 and Official Guide 2023, Part 1, Chapter 3, Organisational Structure, The County, Convention, Rule 3.12 Motions. I wish to propose the following for consideration and submission to Annual Congress (Playing Rules Motions); Official Guide 2023, Part 1, Chapter 3, National, Congress, 3.38 Motions (d) Motions to revise Playing Rules may be tabled only in years divisible by five. Any such motion shall be submitted by the date required for submission of motions for the previous year's Congress and shall be referred to the Standing Committee on the Playing Rules for evaluation.

**Background:** It is widely accepted that Gaelic Football games have become very boring, lacking in skill, devoid of progressive play and generally poor to watch. I believe that part of the problem contributing to this deterioration is the "blanket defence" and the playing of the ball backwards even as far back as to the goalkeeper.

<u>Purpose of Motion:</u> To alter the rules of Gaelic Football so that the ball must always be played FORWARD (i.e. NO back passes allowed) BETWEEN the two 20 metre lines. I believe this will greatly change the dynamic of Gaelic Football for the better forcing teams and players to be positive and progressive in their play.

Motion: The ball may only be played forward between the 20m lines. Horizontal or "square" play will be permitted but play that is behind the Player playing the ball shall not be permitted. Once the ball has been played into the area between the two 20m lines it may not be carried or played back behind the 20m line by the Defending Team. Penalty for a "Backwards Pass/Play" between the two 20m lines shall be a free kick from where the ball is received/lands OR where the ball was played from if that is the more advantageous spot to the Attacking Team. If the ball is received or lands inside the 13m line, then the free kick shall be taken from the 13m line at the point closest to the centre of the goals.

Other Rules Affected: (\* This is suggested and not authoritative and subject to review by the Standing Committee on the Playing Rules in accordance with rule). It is suggested that this Motion, if adopted, be considered a "new rule" to be inserted into the Official Guide 2023, Part 2, The Playing Rules of Gaelic Football, Rule 1, The Play as Rule 1.11.

- (a) Official Guide 2023, Part 2, The Playing Rules of Gaelic Football, Rules of Fair Play, Rule 1 – The Play, 1.2, Exceptions (ii) Any player who falls or is knocked to the ground while in possession of the ball may fist or palm the ball away on the ground, and may score by so doing. In the event that the player who falls or is knocked to the ground while in possession is between the two 20 metre lines he may only play the ball forward, or square, i.e. in the direction of the Opposition's goals. He may not play the ball backwards, i.e. towards his own goals.
- (b) Official Guide 2023, Part 2, The Playing Rules of Gaelic Football, Rules of Fair Play, Rule 1 The Play, 1.3, When the ball is not on the ground, it may be played by any part of the body. In the event that the player who is playing the ball is between the two 20 metre lines he may only play the ball forward, or square, i.e. in the direction of the Opposition's goals. He may not play the ball backwards, i.e. towards his own goals. In the event that the ball is accidentally played off any part of the player's body by a Team Mate and it ends up travelling backwards as

- a result it shall be deemed to be a backwards pass and therefore a free kick to the Opposition. "Accidental Backpass".
- (c) Official Guide 2023, Part 2, The Playing Rules of Gaelic Football, Rules of Fair Play, Rule 1 – The Play, 1.4, When a player is in possession of the ball, it may be:- (a) carried for a maximum of four consecutive steps or held in the hand(s) for no longer than the time needed to take four steps; (b) played from the foot to the hand(s) -toe- tapped; (c) bounced once, and once after each toe-tap; (d) changed from one hand to the other once, with the original holding hand maintaining contact until the change is completed; [In the event of (a), (b), (c) and (d) above occurring between the two 20m lines the ball MAY be carried backwards by the Player without penalty, however the ball may not be carried back over the 20m line by the Defending Team]; (e) played away with: (i) a fist (ii) an open hand-in which instance there shall be a definite underhand striking action [In this event - (e) occurring between the two 20m lines the ball may only be played forwards, or square. It may not be played backwards.] (f) released for a kick, a toe-tap or a pass with a fist or an open hand. The ball may be knocked from an opponent's hand(s) by flicking it with the open hand. [In the event of the ball being knocked from an opponent's hand between the two 20m lines the ball may only be played forwards, or square. It may not be played backwards.]
- (d) Official Guide 2023, Part 2, The Playing Rules of Gaelic Football, Rules of Fair Play, Rule 1 The Play, 2.9; When a team plays the ball over the sideline, a free kick from the hand(s) shall be awarded to the opposing team from outside the boundary line from the place where the ball crossed the sideline. If that place is between the two 20m lines then the Player taking the sideline kick must play the ball forward. If opposing players play the ball simultaneously over the sideline, or if the officials are not sure which team played the ball last, the Referee, facing the players, shall throw in the ball between one player from each team 13m from the sideline and directly infield from where the ball crossed the sideline. A ball that strikes a sideline or corner flag shall be treated as having crossed the sideline. All players except the player taking the sideline kick, or the two players contesting the throw-in, shall be at least 13m from the ball until it has been kicked or thrown in.
- (e) Official Guide 2023, Part 2, Important Terms and Definitions Football and Hurling; introducing the definition of "Forward, Square/Horizontal and Backwards";
  - 24. Forward When playing the ball, the ball moves in the direction of the Opposition's end of the pitch.
  - 25. Square/Horizontal When playing the ball, the ball moves in a direction that is parallel to the end lines. i.e. across the pitch, neither towards the Opposition's end of the pitch nor the Defender's end of the pitch.
  - 26. Backwards/Backpass When playing the ball, the ball moves in the direction of the Defender's end of the pitch.

#### (Cumann Portlaoise).

The Motion was passed unanimously on a show of hands after being proposed by Peadar Ó Néil and seconded by Liam Ó Fionnalaigh.

An Runaí stated that motions to change Playing Rules would not be considered until 2025 Congress, but that such motions must be submitted to the Standing Committee on Playing Rules prior to 23rd December 2023 for consideration.

9. Strategic Review – Update: C. Mac Eochaidh briefed delegates on the various themes of the review which included Maximising Participation & Review of County Demographics; Coaching and Games Development; Inter-County Teams; Facilities & Infrastructure Development; Promotion & Branding; Financing the Plan and our Laois GAA Community. He outlined that the next steps of the review included further liaison with the main stakeholders and engagement with clubs via a survey that will be circulated to all Clubs early in the new year. He was hopeful of document being completed by next March and that this review will provide a clear vision for our County for the next five years.

#### 10. Any other Business:

- Walsh Cup: C. Ó Greacháín stated that opening round of Walsh Cup versus
   Offaly was scheduled for O'Moore Park on Thurs 4th. January and enquired possibility of some of these games being played in Club grounds similar to Mountrath and Rathdowney earlier this year. An Runai replied that no official venue had yet been submitted for Walsh Cup and they were exploring a number of venues.
- Joe Brennan Referee: L. Ó Rannachain wished to acknowledge the contribution of Joe Brennan, both as a player and a referee and wished him well in his retirement, which was re-iterated by the Chairperson.

I wish to extend a warm welcome all our delegates to our annual Laois GAA Convention and hope we can all reflect on Laois GAA affairs during the past year.

In terms of Inter-county activity, 2024 has to be considered a very successful year on the playing fields by means of our Senior Football and Hurling panels reaching four National GAA Finals. Whilst we celebrate our success in both Allianz League Division 2 Hurling and Division 4 Football finals and welcome promotion to the higher Divisions in 2025, we will reflect on the disappointment of our narrow defeat to Offaly in Joe McDonagh Cup final and our loss to Down in Tailteann Cup final.

Briefly reflect my thoughts on the year past

#### Senior Football

Here we paid the penalty for fielding a much changed panel to play Wicklow in Rathnew and ultimately exited this competition.

With the potential advent of the Football Review Committee's new rules, it would have been hugely beneficial to our panellists to experience these proposed new rules in a competitive environment prior to the Allianz League. It was on the recommendation of the GPA on the basis of



The decision also showed little respect for the Leinster GAA benevolent fund for our injured players, which has greatly benefited from the gate receipts from these competitions.

League - At the outset, the ultimate goal was promotion back to Division 3, which always looks very achievable, but from our previous experience here, every game in this Division was going to be a dogfight and not easily won. Fortunately, we got off to the best possible start with five successive wins against Longford, Carlow and London at home, Wexford in Wexford Park and Tipperary in Semple Stadium and had actually qualified for the League final, prior to our final two games. In our penultimate game, we suffered a narrow defeat to Leitrim at home, prior to finishing the campaign with a comprehensive win against Waterford in the SETU Arena in Carriganore. In the final, we faced Leitrim in Croke Park and avenged our previous league defeat in impressive fashion.



Laois Senior Hurling Team - Allianz Hurling League Div 2 Winners & Joe McDonagh Cup Runners-up


Championship game against Offaly in "Laois Hire" O'Moore Park. Our neighbours outplayed us in almost every sector of the game and were deserving winners.

In fairness to team and management, they gathered diligently to prepare for the Tailteann Cup campaign. I believe this competition to be hugely significant to the GAA calendar and particularly to counties like ourselves, whom at this stage of our development are not competitive enough to compete in Leinster championship as yet and progress in competition of this nature will help us take that next step. The competition format is likely to change for 2026, with a proposed motion to Congress to change competition structure to format similar to what is in operation for our local club football championship, but the purpose will remain the same. I think our extended run in the competition the previous year and perhaps the disappointing manner that we exited last year, helped fuel that enthusiasm and ambition for an extended run in this year's competition.

Our opening games in the Group stage certainly did not portray that enthusiasm, with a draw in our opening game with Carlow and a narrow victory against Wicklow in Aughrim. In our final league game against Fermanagh in Pearse Park Longford, I think we saw a glimpse of the performance that this team was capable of, albeit in a narrow defeat to the Erne county. In our preliminary quarter-final, we hosted New York in Laois Hire O'Moore Park, possibly the first time in our history that we had both New York and London at home in the same year. 



With our promotion, we will now participate in Division 1B for 2025, which will consist of the next seven teams outside the top seven teams based on their 2024 league positions and we look forward to Westmeath, Waterford and Antrim away and welcome Offaly, Carlow and Dublin to "Laois Hire" O'Moore Park.

## Local Championships

As I write this article, our entire schedule is complete with exception of an outstanding ACFL Div 3 Final and our U20 Football competitions and I want to take this opportunity to thank all Club Officers for their

patience and co-operation in completing this mammoth fixture programme.

I want to congratulate Clough Ballacolla and Portarlington on their success in their respective Senior Championship Finals and all our other competition winners, whom are listed in the roll of honour at the end of this report and I wish all those Clubs still standing in Leinster Club competitions the very best of luck.

Briefly some of my observations on our club competitions.

"Senior Hurling Championship" – For 2025, the Senior Hurling championship reverts to a ten-team competition, with two Groups of five, playing each other in a crisscross format. I have reservations about proposed format, but we can certainly review after initial year. Whilst we also require an

additional two dates for scheduling of this new championship, which for 2025, will see us revert from "definitive" calendar dates to "potential" dates for our Senior Hurling Championship, which will be determined pending the exit of our Senior Intercounty football and hurling teams from their respective championship. It will also see the final delayed until after the Senior Football final.

"Palmer Cup" – Coiste Iomána brought forward a proposal to organise a 7-a-side Hurling Blitz in honour of this trophy, which was played on the May Bank Holiday weekend. Unfortunately, only five Clubs participated, but from those that did, the feedback was very good and it is potentially a competition that can be expanded to include more Clubs in 2025. I wish to acknowledge Damian Campion Electrical Contractor for his sponsorship of this com-

petition. The proceeds from the day were later presented to the Laois Hospice, which was very well received.

"Senior Football Championship" - Coiste Peil have proposed a reduction in the number of teams in our Senior Championship to twelve, with Intermediate Championship increasing to same. It is a proposal, I have advocated annually in my report to Convention and with statistics showing that the average losing margin in the past five years increasing from 5 points to 9 points, it is certainly worthy of consideration. It will be a matter for decision at November County Committee meeting and will be interesting to see if the mood has significantly changed on this topic. The one difficulty if passed will be the integration of an increased Senior Football Championship games schedule into our calendar along with our newly constituted Senior Hurling Championship, but such can be overcome. I believe the "B" championship for teams exiting the competition at quarter and semi-final stage respectively and incorporates relegation from both Senior and Intermediate championships are welcome and successful to date.

"Coiste na nÓg" – I want to acknowledge the work of Eamonn O'Connell, Tony Bambrick and their Coiste na nOg committee in their underage schedule of games. I don't believe there were ever was as many underage games played in a calendar year, with the incorporation of "shield" and at times "plate" competitions at all grades ensuring all our young players got additional games, which can only help the development of our underage players.

"Walkovers" - The number of walkovers given by Clubs during the year has reached crisis point. From a Club perspective, I am aware there are circumstances that sometimes dictate such action, but unfortunately, it has now almost become an acceptable practice in many of our league competitions. With regard to our championships, the decision of some Clubs to concede games and worse withdraw their teams from respective championship competitions is in my opinion is totally unacceptable and shows a complete lack of respect for all other Clubs participating in these competitions. We have made proposed amendments to our regulations to punish this practice. Coiste Peil is recommending a separate football competition for "hurling" clubs whose preference is biased towards the small ball and I believe it is certainly worth consideration, even be it on a trial basis.

"Football Review" - In my report to Convention last year, I expressed my concern over the game of football being in crisis and that it was becoming unwatchable with teams operating the slow, monotonous, defensive styles of play. On reflection, I do admit that in comparison to other years, the standard and quality of games in our senior football championship in 2024 was good, albeit many games were onesided, with an exceptional senior football final. The Football Review Committee, under the tutorship of Jim Gavin, have completed unbelievable research and work in recent months, with their proposals on rule changes for decision at Special Congress on Sat 30 November. In my opinion, I think we have no alternative but to adopt them in full on a trial basis for 2025. However, I do have reservations on the capability of them being officiated at Club level with a single match official in operation and I am wary as to whether they may create an even greater divide in standards at Inter-county level.

#### Referees and Disciplinary Issues

I want to take this opportunity to thank all our Referees and our Match Officials for their co-operation and dedication in the successful completion of our fixture schedule. Referees have an onerous task and it is as simple as this - without them, there is no match.

I do not believe any Club Official understands the difficulties incurred and time spent in trying to ensure there is a Referee in attendance at every fixture we schedule, in excess of 1,900 Fixtures in 2024 over a nine month period works out at approximately 50 referees required per week. We are working from a pool of approximately 50 referees, so it is not "rocket science" to understand the problems. One of the ongoing difficulties we incur is the weekly call from several of our Club officials looking to change a fixture date or time after the weekly schedule has been finalised. This has at times created havoc, particularly with a match official, who has his week planned and then we make a change, so naturally he is not best pleased. For 2025, I am suggesting that like some of our other sporting bodies that application for changes to our schedule, will only be accepted where fixtures are brought forward, rather than postponed.

Whilst, we are grateful to our Clubs who supply active referees and who earnestly try to recruit officials, a large number of our Clubs do not have a referee (as listed in Referee Administration Report) and make no attempt either in the recruitment stakes. As a result, I will be making a proposal to CCC for inclusion in our regulations, that such Clubs forfeit "home" advantage for a percentage of their league or championship games for 2025. For example, if a Club has seven League games, the Club supplying a Referee will have four Home games, whilst the Club with no Referee will have three Home games. Referee recruitment and retention is the responsibility of all units of our Association, so rather than continue to complain about appointments and the standard of refereeing in our Club games, I am requesting each Club in the coming year to provide at least one Referee, who they believe to be both competent and suitable for training next January.

It would be wishful thinking to say that our match officials are universally appreciated for the tireless work they do in refereeing our games, and it is alarming the level of verbal and sometimes threatening abuse that is being meted out to them. In spite of the introduction of harsher penalties to eradicate such behaviour, there continues to be an escalation and an increasing lack of respect displayed by some of our Club Officials, Mentors, Supporters and Players towards our Referees and their Officials. The most worrying aspect is that this behaviour seems to be far greater at our underage grades. As Secretary, I have often being asked, what makes a good referee and in my opinion, a good referee is the official who is consistent in his application of the rules and gets the big calls correct on the day. Sometimes our officials do not get all these big calls right on important championship

days and I have sympathy for the Clubs on the wrong end of these game changing decisions, which often cause anguish and despair after the huge efforts, the finance and the time put into the preparation of their club teams. Our disciplinary system is not perfect and no doubt decisions are made from time to time that people don't agree with but at the same time, I honestly believe no referee goes out to deliberately give a wrong decision. From the records, Clubs will see that CCC have dealt with all reported incidents of verbal abuse and will continue to operate a zero tolerance policy towards disrespect for our referees, providing the Referee reports the act in the correct manner. Our Hearings Committee are the final arbitrators within the county for decision on enforcement of disciplinary action. Whilst not always in agreement with some of their decisions, the vast majority of decisions proposed were upheld, underlining once again that despite the perception that it pays to mount a challenge and a loophole will be found, the system is proving more robust than that.

All of our Adult Referees complete an Inservice training course, online Rules questionnaire and Fitness testing. Garda Vetting and Child Safeguarding is also a necessity. In my opinion, we have to continue to try and improve standards and with no disrespect to any official, I think there is room for improvement. I receive calls almost on a weekly basis during the year from disgruntled Club officials in regard to different sectors of officiating, like interpretation and implementation of rules, scorekeeping and the accuracy and the detail in Referee Reports. The potential introduction of these new football rules will

pose further difficulties. I would urge our incoming Referee Administration committee to re-consider having Referees assessed, introduction of in-house training seminars based on previous championship games and introducing a mentoring programme for our younger officials, with additional educational opportunities in the sector and implementing a formal development pathway for our Referees. I think a prechampionship meeting with Club Officers and Team Managers to explain and outline interpretation and implementation of our rules would be hugely beneficial as well.

Our Referee Administrator Vincent Dowling and his Committee consisting of John Carroll, Danny Gorman, Pat O'Connell, Joe Brennan, Tom Donoher, Brochan O'Reilly and administered by Pam Cooney are also deserving of our thanks for their efforts and I have no hesitation in admitting that this is the most difficult and thankless position in Laois GAA administration.

#### "Laois Hire" O'Moore Park and "LOETB" Centre of Excellence

As previously stated "Laois Hire" O'Moore Park is one of our main sources of revenue due to the income received from our internal club gate receipts and rental income from Leinster and Central Council games. In 2024, our stadium was again chosen to host numerous inter-county and club games, and we are thankful to Central and Leinster Councils for placing their trust in us to host such games. The stadiums exposure for such matches certainly supports Laois Hire sponsorship input and our many other pitch-side advertisers.

Our stadium is currently partaking in a Safe County Project audit by GAA National Health and Safety committee, which will include an adequately prepared Event Management Document template, an updated Capacity report, a Structural Integrity report for all structural elements of the ground, a Fire Compliance audit and a site-specific Safety Statement for O'Moore Park. This audit is progressing well and I am hopeful will be completed in early 2025. In present day circumstances, health and safety has to be an integral consideration for all our activities and events undertaken under the auspices of the GAA and we must ensure that the GAA is an exemplar organisation in the delivery of health and safety. To that extent, all our staff have completed mandatory health and safety training as well. As part of this audit and in order to continue to attract the high profile games that we have become accustomed to hosting, we will continue to require the support of our Club volunteers, who must partake in the requisite steward training, which will also be invaluable to your Club in hosting your own games.

Thanks to our financial surplus in recent years, we continue to upgrade our facilities in the grounds to ensure that we can continue to provide spectator friendly facilities and improve our playing areas. During 2024, we installed a new scoreboard, upgraded the stadium PA system and disability area, installed an irrigation system in O'Moore Park and completed extensive drainage works on our pitch. These projects and developments cost approximately €200k. For early 2025, a new energy project is planned, which will include upgrading floodlighting on all CoE pitches to 500

lux and LED lighting and the installation of solar panels on the roof of the CoE building including battery. It is anticipated that this project will incur savings of in excess of €30k per annum. The project is currently being tendered and is likely to cost in excess of €350k. I wish to acknowledge support of National GAA for this project who have committed grant funding of €250k, whilst SEAI grant funding is also being explored. Other projects under consideration for 2025 and beyond include development of stand and viewing area adjacent to Pitch 1 in CoE, development of covered disability area in OMP, astro-turfing ball wall area, hard-core additional car parking spaces in CoE, upgrade gym equipment and development of physio and meeting rooms.

Our "LOETB" Centre of Excellence continues to be used on a daily basis by our Intercounty panels, our Academies, our Clubs, our Primary and Post Primary schools, Camogie, LGFA and for internal Club games. In reality, we do not have enough pitches to meet demand and rely heavily on our partnership with Heywood CS for their facilities almost on a weekly basis.

I wish to acknowledge the support of our local Gardai when required on match days. I thank our Event Controller Tom Jones, Safety Officer PJ Kelly and our frontline Stewards Gerry Kavanagh, Connie Dunne, Andrew Broderick, Danny Gorman, Mick Holohan, Billy Behan, Ann Churchouse, Jim Morrin, Pat Gorman, Joe Nolan, Tom Donoher, Paddy Dowling, William Delaney, Conn Dowling, Mick Kelly, Ollie Byrne and our numerous other voluntary stewards, without whose co-operation and

support we wouldn't be able to host such games.

One of the mainstays of our Event Management team Tom Jones announced his retirement from the role of Event Controller after our Senior Football final. He has served in this role for in excess of 25 years and to state that there has been no major incident during this period is a testament alone to his organisation of events. He has also worked in many Laois GAA management roles over the years and on behalf of all Laois Gaels, I wish him well and hope he thoroughly enjoys his retirement.

I want to pay tribute to our Groundsman Colm McEvoy for his continued upkeep of our grounds in the Centre of Excellence and O'Moore Park. It has been a difficult couple years, with the pitch surface in the stadium, which I hope due to the extensive works now completed that the problems have now being resolved.

Our Caretakers are deserving of our recognition and thanks, Willie Stackpool, who was been ably assisted at times by Pat O'Sullivan when required for ensuring both OMP and CoE grounds are opened and closed for games and training. Mick Glynn was responsible for supervising the organisation of meetings and cleaning of CoE on a daily basis, retired in September of this year and I want to thank him sincerely for his work over and above his duties and hope he too enjoys his retirement. David Mulhare has replaced Mick and I know will prove to be a fitting replacement. I wish to acknowledge the work of our TUS and PCE Group Scheme team, consisting Dan Sinnott, Eddie Kinsella,

Roger McEvoy for their continued upkeep of the stadium during the year. Finally our Safety and Facility Officer John Kelly is also "hands on" in his role and liaises with our Event Management team on a weekly basis, as well as overseeing and progressing the many development projects that we have on an ongoing basis.

#### Finance

Our financial year-end accounts I am pleased to say will again show a surplus for the year. This surplus was achieved due to enhanced team expenses for reaching Joe McDonagh and Tailteann Cup finals. Whilst the audit of our accounts has not been finalised as I write this article, they will show an expenditure of €1 million on the administration of our intercountry panels for 2024. From an administrative perspective, I believe that such expenditure is a huge commitment to provide the requisite resources for our Inter-county teams and do wonder the sustainability of such ever increasing costs for our county in the long-term.

In order to meet the increased demand on our financial resources, I do think another substantial fundraiser will be required in the future. Briefly, I wish to highlight a number of our fundraising initiatives, which we have concentrated our efforts on in recent years. My thanks to all those involved for their contribution to these events—

 Club County Board Draw continues to be our primary fundraising activity and is essential to both our County and Clubs wellbeing. In 2024, our Clubs benefitted to the tune of €885,000, while the County profited to almost

- €140,000. I wish to express a huge thanks to Clubs and their members for their support of this Draw, which will continue in 2025. Again, I appeal for your cooperation in making this your Clubs primary fundraiser for the year;
- Our "NOSTRA Race Day" at the Punchestown Racing Festival in April continues to grow and proved to be a huge success in 2024, where we managed to sell 38 tables, with all guests thoroughly enjoying the Punchestown "corporate" experience. Our thanks to Barry and Kevin O'Loughlin and their company Nostra Systems for their sponsorship of this event. For 2025, we hope to increase our table sales for this fundraising event again, so I would ask Clubs to canvass their racing enthusiast members or members just looking for a good day out to support this fundraising venture. I would like to mention Paschal McEvoy, Bryan Breen and Kieran Leavy for their efforts with this fundraiser:
- "Laois Gaels" is the fundraising arm, that effectively replaced the old "Club Laois" initiative, whereby all funds raised are channelled towards additional supports for our talent academies. In fairness, membership has continued to increase on annual basis, thanks to the efforts of "Laois Gaels" committee consisting of Colm Begley, Bryan Breen, Shane Keegan Paul Dargan, Niamh Delaney and Oonagh Maher. The committee actively promoted Laois Gaels during the year, by means of invitation to our Clubs underage sector to attend a Laois Senior Inter-county League or Championship game, whereby they participated in a meet and greet

with extended panel members. Whilst I might add the experience certainly added to the mayhem, it was an excellent promotion for Laois GAA and very well received by those participating Clubs. Unfortunately, Bryan Breen who has been the driving force behind "Laois Gaels" is no longer able to commit to this role for personal reasons and I just wish to take this opportunity to acknowledge and thank him for his excellent work in this sector.

During the year, we signed up to a Shared Bookkeeping Service, which is a structured platform that enables sharing of books and records in a secure manner for the administration of our accounts. This administration service is facilitated by personnel from the National Finance Department in Croke Park and includes a dedicated finance email address for receipt of payable invoices for entry on XERO financial system. Each county also has an exclusive One Drive folder for sharing other information such as creditor statements, lodgement schedules, accrual and prepayment schedules, bank reconciliation and management accounts. From our own governance perspective, all inputs submitted to this service must be firstly approved by Laois GAA and all payments are the responsibility of Laois GAA, which in future will be paid on a monthly basis by bank transfer. At present in excess of twenty counties are availing of this new service. I have to say the service is a welcome support and delivers comprehensive financial reports and budget comparisons. For Convention, our 2023/24 Financial Accounts will be presented in a slightly different format than we have been accustomed to, which is a change requested by the National Finance Committee in an effort to streamline presentation of all counties accounts. In respect of this, I want to acknowledge and thank Aine McKenna, Adrian Duffy and David Connellan, all from National Finance, for their assistance with this service to date.

Governance has become a central theme in the GAA and has seen the establishment in GAA Rule of an Audit and Risk Committees at Central and County level. The Chairperson of our Audit and Risk Committee is Richard Dunne, whom is assisted on this committee by David Dwyer, John Connolly and Maeve Conroy. The purpose of this committee is to provide guidance and oversight to our Management Committee to fulfil their ever-growing responsibility to deliver and promote good governance, clear financial reporting and risk management oversight within Laois GAA. This is further supported by Michelle McAleer in leading this initiative through her Internal Audit office in Croke Park. In July, we were subject to an internal audit from headquarters, which included an onsite visit. This review was to gain awareness of where county boards are on their governance journey and to provide support through advice and recommendations. I still await the result of this audit, which I am sure will inform us of the needs and structures required to bring our County to full compliance. From a club perspective, governance will also become a priority, whereby compliance with your Club Constitution will be become a necessity. To a certain extent, this process has already commenced with insistence that a Club AGM is scheduled prior to end of November and Club Financial Statements are submitted on conclusion of AGM's.

I would like to take this opportunity to pay tribute to our Treasurer Paschal McEvoy for his time and efforts in this important role, his responsibility in overseeing gate collection at our games on a weekly basis does not go unnoticed. Likewise his assistant Bryan Breen and our former Treasurer Martin Byrne for his assistance and professionalism in preparing our accounts.

#### JP McManus Donation

I think it is only fair that I acknowledge and thank JP and Noreen McManus for their magnanimous gesture in donating a €1,000,000.00 from the JP McManus Charitable foundation, which on their request was evenly distributed between the GAA, Camogie and Ladies Football clubs within our County. Our 48 GAA Clubs, 17 Ladies Football Clubs and 10 Camogie Clubs each received €13,333 from this generous donation. This funding no doubt proved to be a massive boost to our local economy and was a substantial resource for developments within our Clubs and was hopefully spent wisely.

#### Local Media

All our games in the county got more than their fair share of coverage during the year and for this I thank the local GAA correspondents in our local editions of Laois Today, Laois Nationalist and Leinster Express and the various commentators in Midlands 103. We are indeed fortunate to have press personnel, who are passionate about Gaelic games and play a role in spreading our message and promoting our games. Denis Byrne does a magnificent

job on photographs and enhance the work of our scribes while our former PRO Paul Dargan further compliments this with his match day photo albums, which are also very well received.

In recent years, we have successfully streamed our internal club games initially through All Rounder Sport, and for the past two years via Clubber tv. The service provided has been excellent and is a means for our older membership to view our games. Our contract with Clubber tv has now concluded and renewal is presently under review, with a variance of opinions as to whether to continue with Clubber or explore producing our own Laois GAA tv service.

Our website, www.laoisgaa, was upgraded last autumn and now has better functionality for the traffic and user engagement it receives on a monthly basis. We continue to embrace social media with Twitter/X, Facebook and Instagram. Alison O'Kelly from AOK Mentoring has also been engaged to support, plan, organise and monitor all our social media accounts in an effort to better promote Laois GAA and our sponsors, which I believe she has achieved very successfully.

Our PR and Communications committee, headed by our PRO Oonagh Maher, are also deserving of our thanks and recognition. The position of PRO is expanding every year and the role would not be able to function without the assistance of her team which includes Eoin Culliton, Canice McCarthy, Conor McCarthy, Aoife McEvoy and Pat McEvoy.

#### Coaching and Games

The promotion and development of our games is the single most important activity that we undertake and this sector will be dealt with more comprehensively later in this report by our Coaching Officer Brian Quinn and our County Head of Games Shane Keegan.

I want to acknowledge the work of our ever expanding Coaching and Games team for their dedication and efforts to the Laois cause. Our Coaching and Games Steering Committee meet every six weeks and I am confident that we are beginning to make progress under the leadership of our County Head of Games Shane Keegan. Our team includes Donie Brennan, Head of Football; Ross Young, Hurling GDC; Dean Malone, Participation GDC and Brian Ging, Physical Performance GDA and our Games Promotion Officers working with the following clubs - Jamie Moriarty (Portlaoise); Jordan Walshe (The Harps & Castletown); Dan Butler (Abbeyleix, Ballyroan Abbey, Ballyfin, Ballinakill & Ballypickas); John Noonan (Graguecullen & Mountmellick); Cian Moffit (Clonaslee St Manmans, Colt Shanahoe & Borris in Ossory Kilcotton); Ciara Kavanagh (Clonad, Mountrath & Rathdowney/Errill); Daragh (Portarlington & The Heath) and Jason Woods (O'Dempseys & Arles Killeen). It is hoped and planned for recruitment of one additional GPO to cover Annanough, Stradbally and Timahoe.

Tom Hargroves our Head of Athletic Development is responsible for the development and execution of an athletic development plan up to and including our senior intercountry teams. Whilst also involved as Strength and Conditioning Coach with our Senior Football panel, he also works closely with our Coaching and Games team with the athletic development of our academy panels. I am hopeful his role can be expanded to include the delivery of workshops to our Clubs with the purpose of educating our mentors in the athletic development of our underage club players.

I want to thank all our mentors involved in a voluntary basis with our academy panels. In reality, this is where all the hard work starts. As I have stated before, our results at minor football grade in particular in recent years have been disappointing and is worrying for a county that once prided ourselves on our production of minor football panels. Our academy system has been in place for a number of years now and performances should be better. It is an area that our Coaching and Games department are concentrating a lot of their efforts on at present. Whilst our athlete development programme is now up and running and will benefit our panels in the long-term, it is the coaching and tactical element of our games that requires support. Our ongoing struggle is to entice quality personnel with requisite coaching skills to get involved with our panels. I want to emphasise that this is no disrespect to the personnel involved at present, all of whom bring many other exceptional qualities to our squads.

Our Setanta & Ó'Mórdha Óg Programmes were organised again this year and expanded to include U10, U11 & U12 age grades, which was a massive undertaking. This programme allows all kids in these age grades the opportunity to partake in structured training sessions. I want to thank all the volunteer coaches who helped deliver the programmes, the organisational expertise of Brendan Phelan, Liam Ahearn, Des Conroy and Mark Russell and special word of thanks to Clonad Club for the use of their facilities.

The schools of Laois both Primary and Post Primary deserve our thanks for the work they do to promote our games within their jurisdictions. We have developed an excellent relationship with Cumann na mBunscol who do tremendous work in our primary schools and thankfully our relationship with the Post Primary sector, whereby we now have a presence in almost every school, continues to grow on a yearly basis.

I also want to acknowledge Laois County Council for their generous financial contribution towards the employment of our GDA's.

#### Sponsors

#### Strategic Review 2025-2026

It is with regret that we have not finalised our Strategic Review for 2025-2026. I view this as an important document and commit to bringing to a conclusion in coming months. I wish to compliment our Vice Chairperson Kieran Kehoe for his hard graft to date, including the gathering of data from the engagement process with our Clubs. It is planned that the document will now be formatted as a Strategy Statement rather than the traditional Strategic Plan and will incorporate the following themes - Maximising Participation & Review of County Demographics; Coaching and Games Development; Inter-County Teams; Facilities & Infrastructure Development; Communications, Promotion & Branding; Financing the Plan and our Laois GAA Community.

Demographics will be an important element of this review and I want to acknowledge the work of Adrainne McCarthy and her committee comprising Rob Nolan, Grainne McCann, Eoin Culliton and Shane Keegan for their comprehensive report on this matter. This report is included in this booklet and it is intended to present some of its findings to our delegates at Convention. Whilst depopulation will pose problems for some of our Club's survival, the fact that in excess of a quarter of our counties population is now living within the Portlaoise urban catchment area will be another matter for review. It is important that the Clubs identified in this report engage with our Demographics committee to plan for their future.

Club Alignment was an outstanding action from our previous Strategic Review, whereby it highlighted that the process for facilitating players without a particular code in underage grades was inadequate and without any geographical consideration. Nickey Brennan, Chairperson of this previous review has engaged with our Club Alignment sub-committee in recent weeks and it is intended that their recommendations will be concluded in coming weeks, whereby underage players from a Club without a particular code will all be facilitated with another Club.

Hopefully, this strategy will give our Club units and members direction on where the Association wants to be by 2026 and how we plan to get there.

#### Na Mairbh

Every year sees the passing of some great GAA people and this year has been no exception.

## **Sub - Committees Reports**

## **COISTE PEIL 2024**

## **COISTE NA NÓG REPORT 2024**

As I was a late appointment to the role of chairman we commenced planning for the season 2024 in February. As we needed to get formats in place it was decided to mainly follow last year's systems as this had been favourably received by the clubs. As in the previous year, Development competitions were held for clubs second teams

Having formed a new Coiste nÓg committee we reviewed the feedback and data on previous competitions and proposed both league and championship competitions in both codes at all age groups to the Competitions Control Committee (CCC) and for ratification by the County Committee. The leagues were graded with a view on previous performances and also to ensure that all teams got a similar amount of games played at each age grouping. As there would be a large number of players unavailable to their respective teams due to County Minor team commitments it was again decided to run the u17 Leagues as development leagues. Our league competitions finished in late May/ Early June with most finals being played in the LOETB Centre of Excellence, A small number of finals were played at club venues and our thanks goes out to the people who made these days such a success for the teams involved. I personally was delighted to see that our u13 development competitions were a success with blitz nights held at LOETB Centre of Excellence with over 200 children taking part. This competition is designed for children of a possibly different stage of development to get as

much football and hurling as their peers without the huge pressure of results and league places. With this in mind I would appeal to our club mentors to ensure that EVERY child plays equal time and that development matches are treated in the way they are designed

Our Feile hurling competition was scheduled for the weekend of the 19th, 20th, and 21st of April. After a challenging spring weather-wise, it was heartening to see the efforts that our host clubs made to make their grounds available and in immaculate order and I thank the clubs involved. Our football Feile was played on the weekend of 10th, 11th, and 12th of May and once again I thank the host clubs involved. All Feile semi Finals and Finals were played in the LOETB Centre of Excellence and our winners represented the county well at the Regional and National events.

And so onto our Championships. As we came to the end of our leagues, Coiste Na nÓg commenced a very thorough process of grading teams for their championship groupings. This grading was done with a mixture of review of league results and with the input of experienced people who had gained a lot of knowledge of the teams involved through attending matches and speaking with various people throughout the County. While every effort was made to ensure an equal grading I'm sure that there were some anomalies and Coiste na nÓg would welcome the input of clubs prior to next year's grading's in order to

ensure an equal grading for the clubs of different levels. Our competitions progressed well over the summer with Cup, Shield, and Plate competitions taking place throughout September and into October in LOETB Centre of Excellence. The object of multiple competitions in each age grade was to ensure that all of our players got as many meaningful matches as possible as late into the season we could manage. Unfortunately, we were unable to accommodate our "A" finals in O Moore Park as we had in previous years. This was due to remedial work which was carried out on the pitch drainage which meant that large areas had to be reseeded. Advice from our maintenance people and the drainage company recommended that we drastically limit the number of matches played on the surface and so our finals were scheduled in the LOETB Centre of Excellence. Both of our minor "A" finals were played as curtain raisers the Senior finals and the players rose to the occasion and provided the crowd with two excellent finals. Disappointingly the "C" grade of the u17 football championship fell by the wayside and was not completed.

Once again I refer to our Development competitions at both U13 and U15. These competitions are hugely important and run for the benefit of both clubs and players at a time when retaining players is a challenge. The competitions are designed so that all players have access to competitive matches without the pressure of winning a specific competition. Players develop differently and we must be conscious of this so that no player feels excluded or not part of a team no matter what their level of ability. I again appeal to clubs to

treat our development competitions in the spirit in which they are designed, not as a win at all cost exercise. Children face many difficulties in these challenging times and our clubs can be a place of inclusivity and safety and if we can keep children involved in sport we will reap the benefits of this in our communities in years to come. Our development competitions will continue next season and I ask all clubs to consider entering teams if their numbers allow.

A review of our 2024 competitions will take place and our committee looks forward to working with the clubs in order to put in place suitable competitions for all our players in 2024. During the past year we again increased the number of games played at underage level in Laois which I feel is a positive development. I understand that there may be difficulties facing some clubs with regard to fielding teams at different grades and I would ask clubs to engage with Coiste na nÓg and our County Board to seek solutions to ensure that all players get to participate in our games. While ensuring that all players play it is very important to remember to try to manage the workload of certain players. Our most talented may be faced with dual code commitments and also faced with playing in two age grades in a certain year. Add in commitments to County Academy squads and it's easy to see that these players may be overworked.

I wish to put on the record my sincere gratitude to our referees and officials. With extra games comes extra workloads for our officials. From our go games up to minor level there was an incredible com-

mitment shown to ensure that all games were officiated. I witnessed first-hand, referees changing matches at the 11th hour to suit others in order that every match went ahead. A large part of this is due to Vincent Dowling and his referee's coordinators so a big thank you to them. To our young whistlers who are starting out on their refereeing journey thank you. I do wish to address the issue of respect of our referees. Our games depend on our officials and it is of utmost importance that we as adults show respect for our officials. I have been troubled to hear of refs being spoken to in less polite terms at times and sometimes abused. This trend must be reversed as our children are learning from their trainers and parents so good example must be set to them. I would ask all of our clubs to try to address any issues they may have in this regard.

As is the case with taking up any new position I had to lean on and seek help and guidance from various people and I would particularly like to mention the fantastic work of the Juvenile secretary Tony Bambrick. Every enquiry was dealt with promptly and clearly and his wealth of knowledge of past results, of leagues, of structures is unrivalled and he was always at the end of the phone should the need arise. To the four People who took the call at the start of the year and agreed to be part of Coiste Na nÓg, Mark Russell, (Borris in Ossory/Kilcotton) Mike Langton (Barrowhouse) Darren Hennessy(Annanough) and Colm Clear (Portlaoise) thank you. To my colleagues on the county Board and various committees I say thanks. Whether it was a quiet word or a steer in the right direction it was appreciated. Thank you to the Staff of the LOETB Centre of Excellence whom always accommodated us and had pitches, dressing rooms etc. available to us for various finals and events. To all of our fantastic volunteers, stewards and officials without whom our matches could not have taken place. Your help does not go unnoticed and you are as important to the development of our young players as anyone else. I also wish to thank PJ Kelly and Niall Handy for their help and guidance throughout the year. Sometimes we take for granted the fact that fixtures are in place, Refs turn up and results and league positions are put up, this is due to the tireless work of the office administrator Pam Cooney so a huge thank you is deserved to her. Finally to our clubs. I have enjoyed meeting the various people involved with our juvenile clubs whether at matches meetings or just through phone call. Thanks to all the mentors and coaches and parents who give their time freely and pass on their knowledge for no other reward than the satisfaction of helping their clubs and young people. # COISTE ÉISTEACHTA LAOISE (LAOIS HEARINGS COMMITTEE) REPORT 2024

As I submit this report, I am able to account that we had a busy year to date with 11 meetings inclusive of 2 Teams calls where required. 2024 saw a 50% decrease from the number of meetings we had in 2023. This throws up two questions to be answered, 1.has the number of infractions decreased or 2, there was insufficient evidence to appeal a decision by the CCC and bring a case to the Hearings Committee (H.C.). The committee are hoping that both assumptions and logical conclusions are true, that infractions by players and mentors have decreased, and clubs have realised that without sufficient and compelling evidence the H.C hands are tied and are bound by the rules of the association.

For the H.C of 2024, the last hearing to date was held on the 10th of October at the time that this report was being prepared. The Committee led by our Chairman Micheál Condron commenced this season's duties on the 24th of January where the committee was asked by the Provincial Council to hear a case from another county. A total of 4 Transfer appeals were heard in late March 2024, all of which were ruled out of order.

Our first disciplinary hearing took place in May 2024 and the requests slowly increased as the leagues and championships in both codes and all levels commenced. In all cases, the H.C was not aware what penalty had been proposed by the C.C.C. and any sanctions imposed by the H.C. were based solely on the evidence presented in accordance with the applicable rule. To all club officials again please note that, a referee's decision can only be overturned in accordance with Rule 7.3 (aa) (vi) "A referee's report, including any Clarification thereto, shall be presumed correct in all factual matters and may only be rebutted where unedited video or other compelling evidence contradicts it. The H.C understand that there are times when individuals are disappointed with the outcome of their hearings but hope they will agree that they are always treated fairly and with respect and understand that decisions reached are always in accordance with an Treoraí Oifigiúil.

On 4 occasions in 2024 video footage has been utilised as evidence, in 3 of those cases the C.C.C decision was overturned. On 4 separate cases, clarification was sought from the referee about infractions that occurred, and 1 of the 4, where the referee's resultant clarification had the outcome of changing the original decision of the CCC. The decisions by the H.C are not a personal on a referee nor do they in any way disrespect the referee. The table below outlines the number of cases heard to date in 2024 and where sanctions were imposed.

The Hearing Guidelines were again sent out to all clubs at the start of the 2024 season and this had a positive effect on the

The H.C would ask all club officials to revisit these guidelines for 2025 before a Hearing request is sought, this is to ensure that unnecessary hearings discontinue, and it also gives club officers clarification and guidance of the procedures before they come to a hearing. If at any time, there is a question or clarification requested by a club official or player, please feel free to contact any member of the committee, as we are there to assist in these matters where we can.

I would like to thank all the individual players and club representatives for their courteous co-operation in their dealings with the Hearings Committee this year. My thanks to the representatives of the C.C.C. for their courtesy and consideration in their attendance at these hearings. I would also like to sincerely thank and acknowledge the role of our County Secretary, Niall Handy and our Administrator, Pam Cooney, in the preparation of paperwork and for liaising with the H.C and referees when clarification of their reports was requested. Their assistance in this regard is very much appreciated. My appreciation and thanks go to

County Chairman P.J Kelly where he was required to attend when Niall was unavailable. My gratitude goes to the members of this year's H.C, Micheal Condron, Tom Jones, Alex Stenson, John Scanlon, Walter Hovenden, and Michael Lennon who gave so generously of their time whenever they were called upon, at very short notice more often than not.

To every member of Laois GAA who I have had the opportunity to meet during 2024 in this role, thank you for the courtesy you have shown me and the H.C, I hope we have always done our best to be fair and supportive to everyone that we engaged with.

I wish you all a very happy and healthy Christmas and all the very best in 2025.

Our GPO's continue to work hard in the areas of Primary School Coaching, Post Primary Coaching, Club & Coach Development, Club Camps and Physical Development.

We would like to thank the many club volunteers who have worked alongside our GPO's to help steer and guide them based on their clubs key requirements.

We are currently have three clubs still waiting on the replacement of their GPO and I am working hard on trying to find a suitable candidate.

To this end, can I encourage all clubs to consider whether they may have some suitable GPO candidates amongst their own club members, and if so, please contact me with your recommendations.

# 3) Formal Coach Education

Introduction to Coaching Gaelic Games (ICGG)

In 2024, we have delivered 22 ICGG courses to date. These break down as 6 Centre of Excellence based courses, 8 club based courses and 8 transition year schools' courses.

We will continue to run Centre of Excellence based courses in the first quarter of the 2025. These dates are currently being publicised and circulated and registration is open to all club members.

We are also more than happy to come to your club to put on an ICGG course at a club's facilities, provided they can assure us of 10 or more sign ups.

It is worth remembering that the ICGG course is a mandatory award that must be held by all members of your club who are involved in a coaching capacity.

We attempt to make this course as practical and enjoyable as possible in the hope that it will be seen as just the first steps on a new coach's journey.

#### Award 1 Football & Hurling

In 2024, we have delivered 5 Award 1 courses. These break down as 4 Centre of Excellence based courses and 1 club-based course.

We will be running one Award 1 football course and one Award 1 hurling course in the first quarter of 2025. Again, these dates are currently being publicised and circulated and registration is open to all club members who have already completed the ICGG course.

The Award 1 course has been designed to take account of the different playing capacities that exist between children (up to 12 years), youths (age 13-18) and Adults (age 19+) and the competencies that a coach is required to display when working with each of the playing populations. Therefore, coaches can specialise in coach-

ing the particular players that they are involved with.

#### Growing our coaching base

We currently have 2,676 qualified coaches across our clubs in Laois. We have just undertaken a process by which each club has now received a list of all qualified coaches in their club, whether they be active or inactive.

I would encourage each club to take a detailed look at this list and see if some of those inactive coaches could be brought back inside the coaching net while also encouraging others to think about progressing up the next step of the coaching ladder.

# 4) Informal Coach Education

Informal Coach Education will be divided into two sections for 2025.

# A) Club Workshops

Our Club Workshops will be delivered by our GPO's and GDC's at the club's venue and will cover the following areas:

- 1) Club Player Pathway
- 2) Session Planning
- 3) Nursery Programmes
- 4) Go Games
- 5) Youth Games
- 6) TURAS
- 7) Athletic Development Programmes
- 8) End of Year Reviews

These workshops will run right throughout 2025.

#### B) County Workshops

Our County Workshops will be delivered by guest speakers at the LOETB Centre of Excellence and will cover the following areas:

- 1) Nursery Coaching
- 2) Go Games Coaching
- 3) U13 U17 Coaching
- 4) Football Goalkeeping
- 5) Hurling Goalkeeping
- 6) County Development Squads Coaches
- 7) Athletic Development & Nutrition
- 8) Primary School Coaching
- 9) Future Leaders (Transition Years)

These workshops will run right throughout 2025 but will be front loaded towards the first half of the year.

We are also setting up a mechanism whereby the vast array of coaching content that currently exists within the GAA actually gets to those who most require it; the volunteer coaches are tasked with delivering their clubs sessions on a weekly basis.

In addition to this, knowledge sharing of 'best practice' amongst our clubs, with guidance provided around implementation has the potential to have major benefits for all.

# 5) Go Games

2024 saw an overhaul in how we delivered our GO Games programme, and I am delighted to say that the vast majority of the feedback has been tremendously positive. Below are some of the changes that were implemented.

- a) A reduction in 'per side' playing numbers.
- A more appropriate fixture list based on club numbers, standard and location.
- Splitting of older and younger players within an age bracket to better match up levels.
- d) Set agreed standard rules rather than the home team dictating.

A positive Go Games experience is vital in the journey of our young players, so it is imperative that we do all that we can to facilitate this outcome.

Unfortunately, a very small minority of clubs have been identified as not helping us to achieve this aim. If this continues to be the case again in 2025, these clubs will be removed from invitations to attend Centre of Excellence blitz days, and the O'Moore Park Experience evenings.

# 6) Academy Squads

The Academy Squads continue to be a key corner stone in the development of both our future county players, and the young players that we hope will go on to form the bedrock of our adult club sides.

Our summer training programme, which saw all Academy players involved in morning gym & pitch sessions during their holidays, was, for the most part, a big success. As part of this programme, our U16 football & hurling panels also received weekly educational talks in areas such as nutrition, goal setting, lifestyle and further education.

Trying to avoid clashes between county and club training sessions and games has without a doubt been the biggest challenge in terms of structuring the academy year.

To this end, the Coaching & Games department intend to work extremely closely with Coiste na nÓg to try to come up with the best possible fixtures plan that we can to ensure that our young players are available to their clubs for training and games while still partaking in a comprehensive county academy programme.

# 7) Setanta & Ó'Mórdha Óg Programmes

In 2024, we managed to achieve our aim of running the Setanta and O'Moore Og programmes at U10, U11 & U12 age groups. This was only possible down to the outstanding work of the volunteer coaches who drove the programme.

Particular credit must go to Brendan Phelan, Liam Ahern, Des Conroy and Mark Russell.

While numbers in the Setanta programme continued to hold up strong, we were a little disappointed by the O'Moore Og numbers and would ask clubs to help us out by pushing the initiative in their clubs in 2025 as best as they can.

The opportunity to avail of extra training sessions in a structured environment where they get to play with and against new kids, and be coached by different voices, has endless benefits in terms of their progression and enjoyment.

A massive thank you to Clonad GAA club for the continued use of their facilities.

# 8) Primary Schools

Driving participation in our GAA Clubs by engaging with kids through our Primary Schools continues to be a key focus for us. The roles played by our GPO's here in helping to develop a love of Gaelic Games at a young age cannot be underestimated.

For those clubs still without a GPO, the club-school link has offered an excellent alternative. I am delighted to say that by incorporating three excellent college interns into our club-school link programme alongside our GPO's, every primary school in Laois received a weekly coaching session over the second half of the 2024 school year.

This is a target that we are confident that we can achieve again in 2025.

We continue to work closely with fantastic Cumann na mBunscol committee that we have here in Laois as we aim to support them with current and new initiatives.

As an example, we recently had a brilliant uptake in our 3rd/4th class blitz days that we held in the Centre of Excellence and we look forward to rolling out a new 6th

class training programme, which will be delivered by coaching and games staff, in the new year.

# 9) Post Primary Schools

The Post Primary School sector is an area in which Laois, while a slow burner, has seen some encouraging progression in 2024.

We understand the challenges schools face in terms of getting students and teachers onboard at schools' level and with that in mind the Coaching & Games department are offering their assistance in whatever way we can.

This year, our staff have assisted in delivery of coaching sessions in St Fergal's Rathdowney, Mountrath Community School, Knockbeg College and most recently St. Mary's CBS Portlaoise. Plans are also underway for us to help deliver sessions in Heywood Community School.

In addition to this, we have had excellent take up on our offer to deliver the Introduction to Gaelic Games and the Young Whistlers courses to the Transition Year Future Leaders programmes.

St Fergal's Rathdowney, Mountrath Community School, Knockbeg College, Portlaoise College, Heywood Community School, Colaiste Iosagain Portarlington, Clonaslee Secondary School and Dunamase College Portlaoise all took part in the programme.

We have looked to increase the games programme available to schools, putting particular focus on 1st and 2nd year, by running blitz days in the Centre of Excellence. These have gone very well and have given the students and opportunity to represent their school early in the year.

We have also entered Laois Combined Schools teams in both football and hurling at multiple age grades in an effort to give students an opportunity to play at as high a level as possible.

## 10) Cul Camps

The delivery of the 2024 Kellogg's Cúl Camps in Laois was a huge improvement on the previous year, mainly thanks to our participation GDC Dean Malone.

Dean took control of the co-ordination of venues, recruitment and training of coaches, and generally pushed the overall standards of what should be delivered to ensure that feedback from kids and parents alike was massively improved on the 2023 experience.

We successfully held 36 camps in 35 different venues throughout the county, in which our clubs hosted 17 Football, 10 Hurling and 8 Dual camps with almost 3,000 kids in attendance.

2024 saw our very first county-based Inclusion Cúl Camp take place in the Centre of Excellence, merging two existing inclusion camps from The Rock GAA and Portlaoise GAA into one county camp, with 29 kids taking part. A huge thanks to Laois Sports Partnership for their help in running the camp.

# SAFETY & FACILITIES REPORT 2024

Delegates and all in attendance, I am pleased to present my report as Laois CLG Safety & Facilities Officer for 2024. I'd like to thank all members of the 2024 County Board for supporting me during the year including the staff at the Centre of Excellence.

The Safety & Facilities officer role can be reported upon from two main areas: Support to clubs and development of O'Moore Park including Centre of Excellence.

# Support to Clubs

Firstly, dealing with support to clubs, it The Leinster Council Development Grant scheme opened for applications in September 2024, and I was pleased to help all clubs in their application process. The club officers involved have done a great job in getting grant support for the capital works carried out between Summer 2023 and Summer 2024. I am very hopeful of a positive outcome from Leinster Council by the end of 2024 in this regard.

The national Sports Capital Programme was announced in September 2024 bringing record awards for Laois clubs. Congratulations to all and I will remain available to support them during the construction phase of each development. These developments will make a substantial improvement to the playing facilities across the County which can only be positive for our players development.

I want to thank Michael Reynolds, Patricia Clear and John Browne in Comhairle Laighean for their constant support and advice during the year.

# Development of O'Moore Park & Centre of Excellence

O'Moore Park stadium is in good shape overall, but a few areas were in need of attention. In particular the viewing area for disabled patrons and the aging scoreboard as I mentioned in last years report.

I am proud to have completed the wheelchair area upgrade project during October 2024 with support from the County Board. I believe it is a positive improvement for wheelchair users who attend any matches.

I was also pleased to be able to progress the new digital scoreboard project during 2024 with the support of the Management Committee. I want to thank Jodie Conway, Pascal McEvoy, Niall Handy, Colm McEvoy and initially Richard Kennedy for their support in making this project a reality. The digital scoreboard has been in operation throughout the club championship and has modernised the patron experience. Thanks to the Contractor FSL for their professional implementation.

The Centre of Excellence is a fantastic facility for all our county players and clubs. I commenced an energy review of the facility during 2024 with the support of TippEnergy. The transition to a more sustainable footprint will be an important

part of the CoE complex development into the future. With Niall's help an application was made to Central Council for grant support. A grant of up to €250,000 was approved in October 2024 for the energy project which will include new LED floodlighting to all CoE pitches and the installation of solar to the roof of the CoE building including battery. A supplementary application has been made to Sustainable Energy Association of Ireland (SEAI) via TippEnergy which will further support the project. It is planned to have the project completed by Spring 2025 which is very positive for the sustainable improvement of the Centre of Excellence.

I would like to acknowledge the work of Colm McEvoy and all the grounds staff. Pitches were in excellent condition throughout the year. In addition to the new irrigation system installed in 2023, the decision was taken to replace the drainage of O'Moore park pitch for the long term benefit of the pitch. Works were carried out in Summer 2024 and the benefits of this project will be seen over the coming years. I'd like to recognise Niall and Colm's work in making this project a reality.

Finally, with the need to constantly keep improving and give strategic direction to the future development of the complex, a future development planning process has been kicked off to set out the next phases of development. I look forward to keeping delegates updated on this strategically important process throughout 2025.

I want to thank PJ Kelly, Martin Byrne and Niall Handy for their constant support during the year in relation to all the above projects.

# Stewarding & Safe hosting of games

Once again throughout 2024, I am extremely impressed and grateful for the dedication of all stewards and others who help during games. These are the unsung heroes who give generously of their time to Laois GAA and its patrons. I thank you all for your dedication. Dealing with the public can always throw up issues, but all stewards that I have come across during the year are very courteous to patrons which gives a very positive reflection of Laois GAA.

I want to sincerely thank Tom Jones in particular, for his support during 2024. As Events Coordinator, Tom has led the organising and hosting of all matches for many years. He has decided to step back from his role into 2025 and he will leave a huge gap which is likely to be filled by more than one person. Tom has given endless hours of his time to Laois GAA which I'm sure will be recognised by all. I wish Tom the very best over the coming years.

I would like to thank PJ Kelly as Safety Officer who has been a constant support regarding hosting games throughout the year; and the workers in O'Moore Park who have kept the stadium clean, painted and very presentable during 2024. And finally, I want to thank Pamela, Willie and Michael for their support of me during 2024.

# **AUDIT & RISK REPORT 2024**

Following a period of significant Audit & Risk review in 2023, the Committee maintained this momentum into 2024. The aim of the Committee is to provide guidance and oversight to the Management Committee to deliver and promote good governance across all functions of Laois GAA.

Risk Management is at the cornerstone of the committees remit. The identification of "inherent risks" allows the Committee to address same with a view to reducing these to "residual risks" while in turn improving overall governance. As outlined, this remit is not restricted to a "Financial" Audit & Risk function but across all activities of Laois GAA to identify and mitigate risk.

I would like to take this opportunity to thank the sub committees who met with the committee during 2024 and provided significant insights to both the opportunities & risks across their roles.

A summary of the overview and initiatives recommended to the Management Committee in 2024 were as follows:

### Club Financial Review

For the second year running an assessment of Financial Year End 10/2023 accounts of every club in Laois was undertaken by the committee with each club being assigned a level of risk depending on the clubs current financial performance and their overall financial position. There were a number

of clubs who moved between risk levels when compared to their FYE 10/2022 accounts and level of information provided. Reports will issue to each club in this regard in the short term.

Following the FYE10/2022 review and findings, the Committee introduced a Financial Template to all clubs who were instructed to adopt same so that there is a uniform Financial reporting system across the county. A number of clubs satisfactorily produced their FYE 10/2023 accounts on the new template, however, their is a gap that needs to be addressed where clubs did not engage with the new template. The financial position in a no. of clubs continues to be difficult to establish in the absence of a Balance Sheet.

I would encourage all clubs to adapt the new Financial Template and if any guidance is sought on completion, please reach out to the Committee via the County Secretary. We are striving for best in class approach to financial reporting to drive improved governance across the club population through this uniform approach.

# Coaching and Games Officer

The Committee met with Shane Keegan, Head of Coaching & Games to establish what what risks have been identified since Shane took up this position in June 2023.

Shane brought the Committee through a SWOT analysis recently completed for

presentation at Provincial level which brought to light the strong work being carried out in Laois to progress our games.

There was one area identified as a key risk to the Coaching and Games function and that is in the area of Post Primary schools. The Post Primary player development pathway in Co. Laois is not at a sufficient level to drive progress at inter county level.

The Committee share this concern raised as it has been a recurring theme identified since the Audit & Risk Committee was established.

Given Post Primary GAA competition is a significant pathway for player development and with the notable lack of Laois schools competing in "A" level competition, we deem this to be a fundamental risk.

There is a Proven link from Post Primary success to Inter County success and a lack of competitive games and dual approach to player welfare between inter county coaching teams and Post Primary Schools level hinters their development at a crucial stage of life.

The Audit & Risk Committee held subsequent meetings to discuss and draft a recommendation on Post Primary strategy which has been recently furnished to the Management Committee for due consideration.

Strong fundamentals are evident in Laois Primary Schools, through a very healthy Cumann na mBunscol programme, which is dually fostered by clubs from Nursery through to Go Games etc. The benefits of this investment in Primary School chil-

dren will continue to be unravelled by the issues encountered at Post Primary level if not addressed imminently.

# Refereeing

In a similar vein, the Committee consulted with Maurice Deegan on the remit of Refereeing in Laois to establish what pertinent risks are facing referees, and to establish what accountabilities and development pathway gaps exist. A recommendation paper has been submitted to the Management Committee for due consideration.

The overarching recommended approach is that a working group be established to assess the SWOT analysis outlined in the furnished paper. Consideration to be given to the areas of weaknesses and opportunities that can be addressed and initiatives put in place to maximise the opportunities for improving refereeing standards. A key driver of this analysis will be to increase the refereeing population and implement a formal development pathway for Laois referees.

## Management Committee

The Audit & Risk Committee met with the County Secretary and County Treasurer to review Laois GAA financial performance during the year vs. budgets furnished to Croke Park.

The Committee found there to be a satisfactory performance vs. budget and significant cost controls and monitoring in place which is satisfactory. The key risk to Laois GAA is the incremental cost of funding inter county teams. It is acknowledged by the Audit & Risk Committee that this is a macro issue across all counties, however, close monitoring of same is required to ensure Laois GAA maintains a surplus position in each Financial year.

It is important to note, that the success of the Senior Footballers and Senior Hurlers in reaching national finals in 2024 resulted in generation of additional income. The Committee wish all our inter county teams continued success into next season and recommend a strong balanced approach to funding of these panels through prudent management which was evident in the past 12 months, albeit at an increasing rate as outlined.

It is also a function of the Committee to review external Auditors findings on the Laois GAA accounts and an independent meeting has been requested to review FYE 10/2024 position. The Committee had interaction with the Auditors prior to finalisation of the 2023 accounts with a satisfactory outcome.

Finally, I would like to thank committee members Maeve Conroy, John Connolly and David Dwyer for their time, guidance, enthusiasm and initiative they brought to this important function during 2024. We are looking forward to 2025 to maintain our focus on mitigating risk across Laois GAA activity to promote a culture of strong risk management.

A key focus of next year will be the completion of a look back exercise on recommendations submitted to the County Board to date to establish how risks identified have been mitigated and to investigate underlying issues where inherent risks still exist.

# **CHILDREN'S OFFICER REPORT 2024**

Safeguarding Training.

This was a very successful year. Deirdre Hurley was always available to all clubs and to the county board to facilitate this training, sometimes at short notice. She was also available to clubs throughout the year to discuss what is acceptable behaviour and what is not acceptable.

The safeguarding training is only valid for three years. It can be renewed through face-to-face or online training.

I would like to take this opportunity to remind all clubs of the requirement for upto-date vetting certification in 2025. Only vetting approved in 2022 & 2023 & 2024 is valid for the 2024 season. Only vetting letters provided by the GAA, LGFA, and or Camogie are acceptable. This vetting is also and safeguarding is also valid for work within primary schools where there is no GPO available to the school. I would remind all clubs that the coach assigned to the relevant primary school has a valid vetting, safeguarding cert and coaching qualification.

All clubs where they participate in Independent teams must have open communication with the lead club and ensure that only suitably approved coaches/officials are in place for all games and training sessions. In the same way where an official/coach is recruited from outside the club(s) each executive is responsible for ensuring that all officials (coaches / mentors / referees / umpires etc) are suitably vetted and trained. For all adult teams where at least

1 under 18 player is training with the team the safeguarding requirements apply without exception.

It is essential (as part of legislation) was all clubs have appointed a Children's Officer and a Designated Liaison Officer. These are not optional appointments.

We request that the Children's Officer email address should be used by all clubs as this is the only method of approved communication in line with good governance and GDPR rule for communication especially of person's personal data. I want to take this opportunity to request that all clubs change email passwords when a new officer is appointed so that the old officer no longer has access to the email associated with the role. This is not a personal email instead it is a "work email" and should only be used in this circumstances.

A disappointing aspect of 2024 for me is the increased use of negative / abusive language on the side-lines and in games in Laois by supporters, players, game officials and appointed officials. We need to remember that we are playing our games with either young people playing and or watching and we are role models for all our young players and supporters.

I would implore all clubs to ensure that this behaviour is not accepted and that any club where this behaviour occurs manage it in accordance with the Safe Guarding protocols. We need to remember that our players / mentors / official's do not deserve / expect to be a recipient of any abuse (verbal or physical) and it is not necessary. As a parent would you accept your child being verbally abused? Would you allow them to be in the environment where verbal aggression is ok? If no is the answer to these questions then we need to better manage our behaviour at games, training sessions and stop this negative behaviour. There is no place in the GAA (and our sister organisations or any other sporting environment or society) for this behaviour. If this behaviour is not accepted in normal everyday society, it is not accepted within the GAA in any circumstances.

I wish to take this opportunity to thank all the club children's officers for their diligent work in their own clubs and with independent teams this year. The conversations we are having locally are a positive reassurance to me that the role within each club is held in high regard and is viewed as essential to good club governance. Within Laois Co. Board the role of the children's officer has now evolved to supporting the clubs and ensuring the county development structures/teams are compliant with all safe-guarding rules. I wish to thank Deirdre Hurley for her work in Laois GAA and her excellence in delivering safeguarding training.

In 2025 all clubs will be requested to complete the Child Safeguarding Statement and Risk Assessment, (last completed in 2023). This assessment is completed every two years. It is important to remember that without an updated approved statement on show in every club grounds, the club will not be able to host games and training. This statement is a Legal Requirement as defined in the 2015

Children First Act and is not an opt-in opt-out requirement.

To conclude I would like to take the opportunity to thank my club Shanahoe for nominating me to the role of Laois Children's Officer over the last 10+ years. # Staying Well - On and Off the Field

This year, we conducted a highly successful workshop aimed at supporting our referees, both on and off the field. This

workshop was the first of its kind in the country which focused on various aspects of referee development, including mental health, stress management, and techniques for handling challenging situations during matches. The positive feedback we received highlighted the need for ongoing support and resources for our officials.

As a result of the insights gained from this workshop, we have put forward several recommendations to our county executive. These initiatives will aim to enhance the experience of our referees and address the challenges they face, ensuring they feel valued and supported in their roles.

Prioritising the mental health of our referees is crucial, as it directly impacts their performance and overall well-being. We urge every club to fully embrace the 'Give

Respect, Get Respect' initiative. This program fosters a culture of respect and support, not only for referees but also for all club officials. By creating a respectful environment, we can help ensure that our referees feel safe and appreciated, ultimately benefiting the entire GAA sporting community.

# **Health Screening Events**

This year, we successfully conducted two full day heart screening clinics in our Centre of Excellence, providing essential health checks to a total of 89 young athletes in our development squads. Out of those 89 we had 3 requiring follow up tests and a cardiology review. Our goal is to raise awareness about the importance of these screenings and the need for early intervention should any issues arise. By running these clinics regularly, we aim to identify any underlying conditions, ensuring players receive timely support. This initiative not only promotes the health and safety of our young athletes but also offers peace of mind to both players and parents as they engage in sports.

# Sun Smart Dispensers

This year saw the installation of Sun Smart dispensers in our county grounds to promote sun safety. These dispensers will provide free sunscreen to all members and visitors, encouraging everyone to protect their skin during outdoor matches and events at the COE. By prioritising sun safety, we aim to raise awareness about the

importance of sun protection and help our GAA community enjoy a healthier, safer experience in the sun.



#### The Year Ahead

In 2024, the Health & Wellbeing Committee will continue to encourage and support our clubs in implementing health-promoting initiatives within their communities. We will strengthen our connections with national and local support services, as well as the dedicated Healthy Club Officers in our clubs.

Our plans for 2025 include:

- Ensuring every club in Laois has a dedicated Healthy Club Officer.
- Requiring all clubs to adopt a critical incident plan and a substance abuse policy.
- Encouraging participation in the 'Clean Air Around Us' initiative to promote a smoke-free environment in all our club grounds.

- Rolling out the HEED & Substance Misuse educational and awareness program for interested clubs and their coaches/mentors.
- Promoting the 'Give Respect, Get Respect' initiative to foster a culture of respect.
- Launching educational programs focused on mental health, and raising awareness about drugs, alcohol, gambling, as well as diversity and inclusion.

These initiatives will enhance our clubs' commitment to health, safety, and community well-being.

# **FIXTURES REVIEW 2024**

#### Introduction

In compliance with Rule 3.18 (iii) of the GAA Official Guide, the role of the fixture analysts is to

- Review the adult fixtures programme for 2024
- Carry out a consultation process with the clubs through a questionnaire
- Make recommendations for changes to be considered by Laois CCC for 2025

#### Review of Adult Fixtures

Following an analysis of fixtures, the review makes the following observations:

- Dedicated weeks for both football and hurling worked well in championships
- Football (ACFL) and hurling league (ACHL) games on the same weekend poses challenges for dual clubs and is a player welfare issue.
- Football leagues need restructuring specifically the 2nd phase of Division 1, 2 and 3
- The level of walkovers in Junior A Football Championship (JFC) needs to be addressed
- Senior B football competition was taken seriously and worked well
- A walkover in the Senior Hurling Championship (SHC) in 2024 is a cause of concern, in light of the decision to increase the numbers of teams from 8 to 10 for 2025
- Any decision to increase the number of rounds in the Senior Football Championship (SFC) needs to take account of the welfare of dual players

#### Consultation

As part of the review, the clubs were consulted and requested to complete an online questionnaire. A summary of the key findings are as follows:

- · Only one third of clubs responded
- The majority of respondents favoured making changes to ACFL 1, 2 and 3
- Some appetite to reduce the number of teams in the Senior Football Championship (SFC)
- Hurling and football leagues should be played on different weeks
- One suggestion is that lower grade competitions should start later in the season
- Player welfare was raised (specifically playing games on consecutive days)
- Clubs are keen that the Co Board deal firmly with walkovers in championships

#### Recommendations

The following should be considered when framing fixtures for 2025:

- Changes to the SFC format needs to take account of the demands on dual players
- Restructuring of JFC is required
- All clubs in SHC must play at least one round before commencement of lower grades
- Senior, Premier Intermediate and Intermediate hurling should finish on the same weekend
- Separate league weekends for football and hurling leagues as far as practicable

- Standalone football competition for clubs with no real interest in promoting the game
- Penalties in place to act as a deterrent for walkovers in championship games

# NA RÚIN (MOTIONS)

- In order to bring <u>Byelaw 7 "Playing Restrictions"</u> closing date in line with <u>Byelaw 6 "Transfer Byelaw"</u>, it was agreed to bring forward motion to amend Byelaw 7 as follows (change in bold italic)
  - (a). Subject to Riail 6.7, (c), T.O. 2024, the CCC shall process and make decisions on applications received on or before 31st January in any year for permission for an Adult player from an exclusively Football Club to play Hurling with a Dual Club or a player from an exclusively Hurling Club to play Football with a Dual Club.
  - (b). Subject to Riail 6.7, (d), Exception (1), T.O. 2024, the CCC shall process and make decisions on applications received on or before 31st January, in any year for permission for a Club's Underage (up to including U20 / U21) players who may be without an Underage Team in a particular Grade or Code or who may be from an exclusive Football Club to wishing to play Hurling with a Dual Club or a player from an exclusive Hurling Club wishing to play Football with a Dual Club. (CLG Laoise)
- 2. Proposed changes to Byelaw 8 Grading as follows:
  - (A): That the number of player's teams have to submit for their first and subsequent teams (by Feb 28th) should be reduced to 13 players;
  - (B): That the number of players submitted for Championship panels be reduced to 15 players;
  - (C): That the date for submitting championship panels be put back from May 14th to June 21st and that clubs be allowed to amend their Championship panel at this time. (CLG Sráidbhaile)
- 3. Proposed amendment to be included in Byelaw 8 Grading as follows: That after two championship rounds clubs would be allowed to apply to regrade a maximum of two players subject to approval of the CCC. To be eligible to be considered for this regrading, a player must not have started both of the games played at the higher grade. (CLG Sráidbhaile)
- 4. MOTION: Any players from a single code Club currently registered and attached to a second Club to avail of hurling/football be allowed continue with that Clubs for the duration of their playing career. REASON: This rationale for this is in light of current and upcoming Club alignment moves, it has to be recognised that there are players who have been playing with Clubs from Nursery up to U13 for up to 6 years in some cases. These player should be allowed continue with that Club rather than being uprooted to another Club at a young age, which could cause player dropout. All other players post club alignment becoming effective be directed as per wishes of Laois GAA. (CLG Páirc Raithín an Usice)
